**Course Description:** This course provides a supervised work experience for CDA candidates. Students are expected to demonstrate competence in the CDA functional areas: safety, health, learning environment, physical and cognitive development, communication, creativity, guidance, self, social, families, program management, and professionalism. Students are required to work in a licensed child care center with infants and toddlers, preschoolers, or a licensed family child care home. Observation will be completed at the work site during regular hours of operation by an instructor who meets CDA advisor requirements using standards for the Child Development Associate national child care credential.

1. Demonstrate appropriate practices in a group setting of children in the CDA functional area of safety including the safety of toys and materials provided, supervision of children and emergency procedures.

Demonstrate appropriate practices in a group setting of children in the CDA functional area of health including general hygiene practices to decrease the spread of disease, encouraging health maintenance habits in children, healthy diapering/toileting procdures, providing meals that meet the developmental needs of the children and providing developmentally appropriate rest experiences.

3. Demonstrate appropriate practices in a group setting of children in the CDA functional area of learning environment including providing a well-arranged space, developmentally appropriate materials, appropriate organization of materials to facilitate play and appropriate schedule of routine.
