- 4. Recognize ethical dilemmas.
- 5. Identify appropriate strategies to address ethical dilemmas.
- 6. Describe the differences in role, function and supervisory relationships of Physical Therapist and Physical Therapist Assistant.
- 7. Recognize the possible effects of culture and/or individual differences on behavior and communication.
- 8. Define human trafficking.
- 9. Identify red flags that would identify a victim of human trafficking.
- 10. Identify factors that influence the level and type of supervision of a physical therapist assistant by a physical therapist.
- 11. Identify the components of patient management model used to develop a plan of care.
- 12. Recognize the possible effects of culture and/or individual differences on behavior and interactions.
- 13. Describe the possible cultural and individual differences that influence verbal and non-verbal communication in the health care setting.
- 14. Identify effective conflict management strategies.
- 15. Write a clear, concise, and legible patient treatment note using appropriate terminology and format.
- 16. Read and summarize a research article.
- 17. Identify federal agencies and laws that affect the role of the physical therapist assistant.
- 18. Identify Michigan laws that affect the role of the physical therapist assistant.
- 19. Recognize components of Michigan laws that affect the practice of physical therapy.
