- 1. Compare and contrast the composition, distribution and legal aspects of prescription and synthetic opioids and analogues.
- 2. Discuss the stigma attached to opioid drug use and its impact on the workplace.
- 3. Discuss the occupations and professions most impacted by the opioid crisis.
- 4. Review and discuss drug prevention as it applies to public health.
- 5. Identify policy gaps in drug prevention, such as the standards of public safety and health programs.
- 6. Identify occupational risk factors that impact mental health and substance abuse.
- 7. Explain the importance of ergonomics in preventing pain, injury and opioid use.
- 8. Discuss the impact of substance use on the worker, co-worker and workplace.

- 9. Discuss employment-based substance abuse programs and their drug and abuse prevention policies.
- 10. Discuss the roles of employers, employees and member assistance programs in drug abuse prevention.
- 11. Discuss the value of peer assistance programs.
- 12. Discuss action planning for workplace improvement and outline elements of supportive workplace programs.
- 13. Prepare and present a lesson plan for drug prevention and response.
